## TERMS OF AGREEMENT

- Pricing:** Actual pricing and availability may vary as the networks are maintained and as determined by the Gateway. Origination and termination zones of a call will be determined solely by the records generated from the network Gateway. Orbit Satellite reserves the right to change prices at any time without prior notice. Orbit Satellite will however attempt to provide 30 days notice in the case of a price rise.
- Renewal:** Orbit Satellite will issue an invoice for the service renewal on the renewal date (12th day of the month). The service fee will be deducted from your nominated account on the 26th day of the month following the renewal notice. Orbit Satellite will attempt to advise you of any new plans to give you the opportunity of changing to a newer plan. Orbit Satellite will deduct funds from your nominated account in line with the service fee for your selected plan. The annual fee is not pro-rata and deducted funds cannot be refunded.
- De-activation:** Orbit Satellite requires a minimum of one month notice from the next billing cycle to finalize your account. De-activation can only be performed with written permission from the account holder. Please contact Orbit Satellite at least one month prior to the end of your contracted period. The annual fee is not pro-rata and deducted funds cannot be refunded. Orbit Satellite reserves the right to SUSPEND or DEACTIVATE any account should payment of account become overdue. Cost of re-activating will be payable by the account holder. Any subscription payments received in advance cannot be refunded. If your service is paid monthly and you have not completed the minimum contract term you will be invoiced the full remaining subscription fees at the time of deactivation.
- Electronic Invoicing:** All invoicing will be produced electronically and emailed to your nominated email address; a \$5.00 fee will apply to all hard copy requiring postage.
- Billing - Period:** Orbit Satellite billing period runs from the 13th of the month to the 12th of the following month. All payments will be deducted from your nominated account on the following 26th day of the month.
- Payment:**
  - Direct Debit:** All payments will be deducted in Australian dollars from your nominated credit card account. Valid credit cards accepted are MASTERCARD and VISA CARD.
  - Account:** All accounts are to be settled in full as specified on the tax invoice. Such payments should be deposited into Orbit Satellite account. Accounts operating outside these terms will continue to incur a monthly late payment fee until invoice is paid in full.
- Included Call Conditions:**
  - Orbit Satellite** will not issue an invoice/receipt or call log, if you do not exceed your monthly included call allowance.
  - If you make more than your included call allowance of calls, all calls outside the allowance will be charged to your nominated account. An electronic invoice and call log will be sent to you. The included call allowance each month/year is totally free for that period only and is non cumulative. In any period if an invoice and call log are not issued, but the call log is required, Orbit Satellite will issue your electronic call log on request at a cost of \$5.00 per electronic copy and \$10.00 per hard copy requiring postage. Charges for this service will be deducted from your nominated account associated with the relevant account.
- Notice of disclosure of your credit information to a credit reporting agency. (Privacy Act 1988)**

Orbit Satellite may give information about you to a credit reporting agency, for the following purposes:

  - to obtain a consumer credit report about you, and/or
  - to allow the credit reporting agency to create or maintain a credit information file containing information about you.

The information is limited to:

  - Identity particulars - your name, sex, address (and previous address), date of birth, name of employer, and drivers licence number.
  - your application for credit or commercial credit - the fact that you have applied for credit and the amount.
  - The fact that Orbit Satellite is a current credit provider to you.
  - loan repayments which are overdue by more than 60 days, and for which debt collection action has started.
  - advice that your loan repayments are no longer overdue in respect of any default that has been listed.
  - information that, in the opinion of Orbit Satellite you have committed a serious credit infringement (that is, fraudulently or shown an intention not to comply with your credit obligations).
  - dishonored cheques - cheques drawn by you for \$100 or more which have been dishonored more than once.
  - that credit provided to you by Orbit Satellite Pty Ltd has been paid or otherwise discharged.
